



Boat and Trailer Storage Agreement

The Concord Yacht Club (“Club”) agrees to allow me, the member, to store my boat and trailer described above on the grounds and adjacent lake area to the Club located at 11600 S. Northshore Drive, Knoxville, Tennessee 37922, commencing on the date of this agreement, upon the following terms and conditions. This agreement may not be assigned or transferred.

A. PURPOSE Boat and trailer storage is a privilege of membership in the Club. The term “boat” and “trailer” includes hull, spars, rigging, sails, engine, contents and equipment.

B. RISK OF LOSS I understand that my boat and trailer is stored on Club premises at my own absolute risk. The Club assumes no responsibility for the boat or trailer and in no way is liable for any loss or damage to the boat or trailer caused by wind, rain, fire, theft, vandalism and any other cause or means. The Club assumes no responsibility for the suitability, strength, or condition of any parking space, dock, mooring, rack or other Club facility.

C. INDEMNIFICATION I agree that insurance of my boat and trailer will be my sole responsibility. I further agree to properly execute and comply with the CYC Liability Insurance Agreement. I assume responsibility for the loss or damage to my boat, other boat or boats, and/or Club property resulting from my fault or negligence.

D. RENTAL CHARGES I agree to pay the rental charges from time to time fixed by the Club for storage of my boat and trailer and in addition will pay any extra charges imposed by the Club.

E. CONDITIONS I accept and will abide by the following conditions:

1. To comply with the published rules of the Club relating to storage of my boat and trailer. Club rules, which are subject to change, may be found in the CYC Handbook published on the CYC website. Violation of rules will be cause for immediate forfeiture and termination of this agreement.
2. To immediately notify the Harbormaster if the boat and trailer is sold or exchanged and to remove the new boat and trailer from Club storage within seven (7) days. (Storage privileges do not transfer to the new boat owner. A new boat owner who is a Club member will need to take their place on the waiting list, based on their Club seniority.)
3. To remove my boat and trailer from Club storage within seven (7) days after termination or resignation from the Club.
4. To remove the boat and/or trailer from the Club storage within seven (7) days after a written request from the 1st Vice Commodore for any such reason as determined by the 1st Vice Commodore and Harbormaster with consent of the CYC Board, including, but not limited to: a) failure to pay any charge imposed by the Club; b) failure to adequately maintain the boat and trailer; c) failure to store the boat and trailer in the space allotted by the Harbormaster and, d) failure to follow published rules of the Club relating to storage of the boat and trailer.

F. BREACH OF AGREEMENT In the event of any breach of the terms of this agreement, I authorize the Board of the Concord Yacht Club, after written notice to myself, to dispose of the stored boat and trailer; including hull, spars, rigging, sails, engine, contents or equipment in any manner the Board deems appropriate, and to apply the proceeds, if any, of such disposal to the settlement of any overdue charges or levies due to the club and any disposal costs, including any legal fees incurred, with any surplus being returned to me.
